Consent information sheet: ACGG Producer Level Baseline Survey

The African Chicken Genetic Gains (ACGG) project aims to catalyze public-private partnerships for increasing smallholder chicken production and productivity growth as a pathway out of poverty in sub-Saharan Africa. We believe that the availability and affordable delivery of brooded and pre-vaccinated chicks that are adapted to typical low-input systems in poor rural communities would greatly increase production and productivity and improve livelihoods, especially for poor women who are the focus of the project. We also believe that the increased production will lead to more access to meat and eggs in rural communities, which will result in increased household animal protein consumption. We want to achieve this by empowering smallholder farmers, especially women, to access their preferred, but more productive chicken breeds that they can optimally manage in their specific agro-ecology and production systems. We plan to work in your village, but we cannot guarantee that you will be a direct beneficiary. However, we plan for benefits to reach existing and future smallholder poultry producers in Nigeria.

The project works in 30 local government areas in Nigeria and you are one of the households selected by a random process for the household survey. The purpose of the survey is for research to get baseline information to design the project's intervention and against which to enable monitoring and evaluation of project activities. The survey will cover current chicken flock sizes, smallholder chicken production systems, ecotypes, current realized productivity levels, husbandry practices and the socioeconomic status of poor smallholder chicken farmers.

This survey also seeks information about demographic characteristics of your family, assets, chicken production, chicken productivity, chicken management, chicken marketing, labor allocation for chicken farming activities, group memberships, access to credit, food security and consumption. We will also ask some questions related to 'who makes what decision in this household', for us to better understand how the project activities can benefit everyone in your household. Participation in this survey is voluntary and humbly request your consent and assistance in responding to the survey.

The information you give for this survey is confidential and will not be given to any other person or used for any other purpose.
